### Rules to participate in Indiana Access to Recovery

Indiana Access to Recovery (ATR) is a SAMHSA Center for Substance Abuse Treatment discretionary grant aimed at expanding the chemical dependency recovery infrastructure in the state to include both faith-based and community organizations that have traditionally not been involved in chemical dependency recovery. We interface with them to help you through your Recovery Consultant and through the Office of Faith-Based and Community Initiatives which is under the Indiana Division of Mental Health and Addiction (DMHA). The DMHA mission is to ensure that Indiana citizens have access to appropriate mental health and addiction services that promote individual self-sufficiency.

To participate in the Indiana Access to Recovery process, you must meet <u>ALL</u> of these requirements:

- \* You have an addiction, know it, and want to recover
- \* You are legally considered an adult able to protect your own civil rights
- \* You LIVE in one of the counties, such as Allen county, in which the program is available, OR <u>you have ever been or currently are in the military service and live anywhere in Indiana</u>
- \* Your total family income is less than 200% of the Federal Poverty Level (\$44,100 for a family of four) or <u>under 500% of FPL (\$110,250 for a family of four) if you are or</u> ever were in Military Service.
- \* You are here because **you** have decided to be here not because anyone is forcing you

To participate in the Indiana Access to Recovery process, you must also meet <u>ONE</u> of these requirements:

- \* You have EVER served in the US Military, regardless of discharge status
- \* You have used Methamphetamine in the last 90 days
- \* You are somehow associated with the criminal justice system, on parole, probation, drug court, diversion agreements, and so forth.
- \* You are or have participated in a "problem solving" court, such as a diversion program in the last 45 days
- \* You are a woman who is now pregnant
- \* You are a woman with at least one dependant child
